## Intergenerational Workforce Communication

On August 9, 2007, Dr. Martha Crumpacker, Associate Professor of Management at Washburn University, addressed a group of 18 members and guests at the Top of the Tower in the second lecture of this year's Professional Lecture Series. Dr. Crumpacker spoke on the importance of "Intergenerational Workforce Communications."

At the current time, there are workers in the American workforce whose ages span more than 60 years. These workers are divided into four generations characterized by two major factors—birth rate and the events of the "times." The four generations are labeled as follows: Traditionalists, age 62-85; Baby Boomers, age 43-61; Generation X, age 27-42; and Generation Y age 26 and younger. Problems come into play when dominant characteristics of one generation are stereotyped by those in other generations. For example the Traditionalist's respect for rules and authority may be seen as being rigid and autocratic by a "Gen Xer." At the same time, the technologically savvy Generation Y member might

be seen as technologically dependent by a Baby Boomer. The greater emphasis on the balance between work and quality of life sought by a Generation X member might make him/her appear to be a "slacker" to the more driven, competitive Baby Boomer.

There are several communication tips that may help with intergenerational communication: When you communicate with a Traditionalist, respect is the key. For Baby Boomers, meet face-to-face whenever possible and develop rapport. With a Gen X, "cut to the chase" and avoid unnecessary meetings. For Gen Y, be positive—even when correcting or critiquing. Although these guidelines may be very helpful, caution must be used to avoid generalizations. Not everyone "fits the mold" of a particular generation. While knowing a person's generation might lend some perspective in knowing where he/she is "coming from," there is no substitute for knowing much *more* about the individual with whom you are communicating than just his/her age group.

### CEC Highlights

The August CEC meeting was held at 5:30 p.m. on August 8th at the Foxridge Cooperative Clubhouse with the following members in attendance: Sabrina Wells, Scott Alisoglu, Walt Darling, Kathy Bohnhoff, Linda Farlow, Fred Baer, Brandi Baer, Larry Barret, Nickie Roberts, Melinda Richter, and Marti Leisinger.

Discussion was held on the budget proposed by President Sabrina Wells. The consensus of the committee was that we should attempt to break even on monthly Professional Lecture Series meetings through cutting some of the costs associated with the meetings. With a few minor adjustments, the budget for the 2007-2008 chapter year was adopted on a unanimous vote. The new budget and a current financial report will be included in the September newsletter.



Other items discussed included the Professional Lecture Series and audio conferences. Scott reported that average attendance at the monthly lectures is approximately 18-25. He will provide a more precise count at the next CEC meeting. Linda discussed the three audio conferences which she has booked for November 14, December 12, and May 7. A conference room at the library will be booked from 12:30-3:30 for each of the days. It was decided that the charge for the conferences would be \$20 for members and \$25 for non-members. Walt suggested adding 2 hours of ethics training to the December audio conference, and he will be contacting Bernie Hayden to see if he is available to speak on that date. Melinda reported that she needed all chapter recognition points for May, June and July turned into her by Friday, August 10 for her report to National. Also, she reminded committee members that yearly chapter reports are due by August 30. Nickie presented the Community Service report. The two events we will be participating in during September are the American Heart Walk on September 15th and the Race Against Breast Cancer on September 29. The Committee voted to pay the registration fee for any member who chooses to participate in the Race Against Breast Cancer. Larry is working on ideas for the March, 2008 PDC and discussed some possible speaker ideas. The first PDC planning committee meeting will be held on August 28 at Celtic Fox.
