Conference Sept. 2nd, 2009 “Current Government Policies Effect on Personal Finance”

On September 2, 2009, the Topeka Chapter will hold a half day conference at the Topeka Shawnee County Public Library from 10:30am – 3:00pm. The conference will begin with a presentation from Anthony Blanco and Jared Gwin, Registered Representatives from the Capital Financial Group. The topic will be on “Current Government Policies Effect on Personal Finance”. Following lunch a two hour audio seminar on grants management is offered in conjunction with the National Association of State Auditors, Comptrollers and Treasurers (NASACT) and the Association of Local Government Auditors (ALGA). Grants administrators operate in a dynamic and complex environment. They face an ever-growing list of compliance issues, closely scrutinized by internal and external auditors. The American Reinvestment

and Recovery Act has raised the “compliance bar” with additional reporting and accountability requirements. State and local governments, not-for-profits and education and research grant administrators are struggling to untangle, interpret and manage the growing list of requirements that comes with the flow of federal dollars. The presenters will cover some of the recent changes related to grant regulations and begin to sort out the new reporting and compliance requirements related to grant funding. These requirements are not only important for grant administrators to know, but for auditors, accountants and other financial

accountability professionals to understand. To share their practical experiences in grants management are Thomas A. Cooley, MS, Chief Financial Officer and Director, Office of Budget, Finance and Awards, National Science Foundation; W. Scott Erwin, CGFM, CRA, Director, Office of Sponsored Programs, Texas State University – San Marcos; and Joseph L. Kull, CGFM, CPA, Director, PricewaterhouseCoopers, LLP. Please join us! Volunteer Income Tax Assistance Program—VITA

VITA is probably one of the most rewarding programs, next to my India mission work, that I've had the opportunity to work on. It was the Topeka AGA that gave me the volunteer bug about 10 years ago. I appreciate the fact that my chapter continues to let me serve as a VITA volunteer, although I am living and working in Leavenworth. Each year we assist between 350 to 500 low income families with preparing their federal and state tax returns. I've been doing this so long that somehow I let an IRS agent talk me into being in charge of a mobile site. I am blessed to have 4 of the most outstanding and committed volunteers (all former accountants) in the state. Equipped with IRS provided laptops and printers our site processes 99% of our returns electronically, including Homestead. The program has afforded me the opportunity to learn how to manage and oversee the preparation, quality control, the actual E-Filing, and when necessary, the correction of rejected tax returns. The one thing that is certain about VITA is that you will get the opportunity to file multiple out of state tax returns. In this last year, we E-Filed 99% of our Federal and State tax returns. Despite the professional development opportunities associated with filing tax returns, the absolute most rewarding aspect of volunteering is that you get to see the sincere appreciation in the eyes of the folks you are helping; it gives purpose.

This year, the Topeka Chapter accumulated more than 29,000 points.
