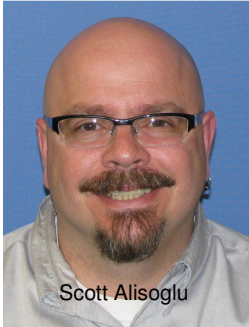


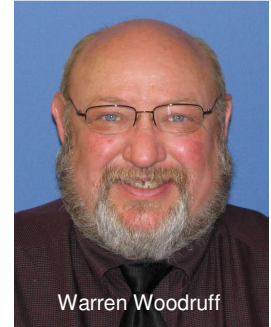

Scott will provide an overview of the City of Topeka's energy efficiency and conservation initiatives, the role of the Sustainability Advisory Board, and the implementation of the Topeka Community's Energy Efficiency and Conservation Strategy. Within the context of the ENERGY STAR program, Warren will present practical ways that households and businesses can reduce energy consumption, and in the process, reduce monthly expenses. The Energy Star Program is one for which Topeka has won several national awards.

To keep inappropriate payments from happening, agencies need to look for ways to automate the reconciliation process so that duplicate or fraudulent transactions can be spotted and prevented. Participants will be able to gain a better understanding of how to reduce risk, increase efficiency and enable regulatory compliance by streamlining the reconciliation and financial control process. The U.S. Coast Guard will also share their experiences of how they are benefiting from automating this process and the cost savings that can be achieved.
